

EMD GUIDE

We are happy to present the EMD guide displays to find out which Airlines and Markets are using EMD through the Amadeus distribution channel.

We can get the information on services for which EMDs can be issued on Amadeus, along with the corresponding detailed information for each service on respective Airline.

Following entries related to EMD Services are available on Amadeus:

EMD Information	Entries
List of Airlines using EMD per Country	EGVD/CIN
Countries per Airline	EGCD/VAF
Services offered by an Airline	EGSD/VAF

Apart from above, we wish to present the enhancement in EMD Guide with new entries and information, as explained below.

New Entries:

- Display only the services issuable by travel agents by using: **EGSD/VAF/TA**
- Access directly to a specific line number of the EMD guide, without being in EMD guide context: **EGSD/VAF/L3**

New information:

- Information related to Exchangeable/Refundable EMDs is indicated by "ONLY FOR MANUAL PRICING" and is applicable to EMDs created manually for example Baggage, Penalty, Pet in Hold and Meal etc.

1. **EGSD/VLH/TA** will provide us the list of services which are allowed to be issued by Travel Agencies, refer below example:
