ELECTRONIC MISCELLANEOUS DOCUMENTS (EMD)

Further to our previous Newsflash as the EMD Guide, we are happy to share the entries for a couple of more services for which EMD needs to be issued frequently.

Mandatory Check's:

- Before EMD issuance, always refer to **EGSD/VXX** (where XX is the two letter Airline code) to get service issuance code and issuance type on SSR or Services segment.

In the above example service code for all prepaid baggage service code is ASVC and service type is in SSR element.

EMD issuance steps for Prepaid Baggage

Step 1: Create the service element entry:

SRASVC-C/0C5/P1, where in ASVC is service code, C/0C5 is the RFIC/SC code

OR

SRASVC-C/0C5//UPTO 66LB 30KG BAGGAGE, where in ASVC is service code, C/0C5 is the RFIC/SC code and UPTO66LB 30KGBAGGAGE is the description in EGSD entry.

Step 2: Price the ancillary service: **FXG**

Step 3: Add form of payment: **TMI/FP-CASH**

Step 4: For pre-validation perform: **TTM/TKT** and EMD issuance entry: **TTM**

EMD issuance steps for Chargeable Seats

Step 1: Pick the chargeable seat from seat map **SM2** and select the seat number

OR

Add the **ST/24K/S2/P1**

Step 2: Price the seat request by entry: **FXG**

Step 3: Enter the form of payment: **TMI/FP-CASH**

Step 4: For pre-validation perform: **TTM/TKT** and EMD issuance entry: **TTM**
