

## **Get more confident on EMD issuance!!**

We wish to share with you answers to Frequently Asked Question(s) on EMD issuance, which will help to cut down on your time and also make your work simpler.

### **1. How to check which airlines are EMD enable in Indian market.**

Entry to check which airlines are EMD enable in Indian market is **EGVD/CIN**

### **2. Can travel agents display EMD issued by an airline office and therefore perform follow- up transaction?**

Yes. This is possible only if an agreement is set-up between the airline and the travel agency.

### **3. Can agent issue a single EMD for services having different reasons for Issuance?**

No. You must have the same reason for issuance for all services of a same EMD.

Nevertheless, you can have up to 16 coupons per EMD, as for E- tickets.

### **4. Can all forms of payment be used?**

Yes. However note that when using FPCC with a pre – approved code you need to enter the credit card number into TSM, i.e.: TMI/FP-CCVXXXXXXXXXXXXXXXXXX/0218/N1111.

### **5. Which transaction can be performed with an EMD?**

Technically speaking the following transactions can be performed on EMD:  
(both EMD-A and EMD-S)

## News Flash

- Issuance
- Display
- Cancellation
- Refund (and refund cancellation)
- Exchange (and exchange cancellation)
- History display

**Note!** Airlines may not allow travel agents to perform all transactions.

### 6. What do RFISC mean?

The RFISC (Reason for Issuance Sub-Code) is secondary code qualifying the RFIC at coupon level.

Entry to display list of EMD services available for Airline.
