**INTRODUCTION OF TRANSACTION FEE BY JET AIRWAYS**

We wish to present to you the Jet Airways' transaction fee model effective 01<sup>st</sup> January, 2018, to replace the standard agency commission. The transaction fee of 3.5% can be collected on the Base Fare Plus YQ Tax components for domestic and international segments in the form of 'OC Tax'.

**Illustration Steps:****Step 1: Create PNR with all mandatory elements and Price the Itinerary**

**Step 2: Perform the FR Entry and save the fare**

FR Entry saves the Historical Fare Records in a PNR along with the entry used to price the PNR and its presence is reflected on PNR Header Tag with ---TST RLR HRF---

**To retrieve the Historical Fare Record (FR), you may perform the entry "RH FR".**

Step 5: Update endorsement (FE Element) with "OC AGENCY REMUNERATION" by cancelling existing FE Element and add new as FENON ENDO/ OC AGENCY REMUNERATION.

**News Flash****Points to Remember:**

- It is mandatory to save the auto priced fare by doing RFX;ER.
- The OC tax must be added in TST as a separate transaction.
- Pricing & Ticketing should be done at the same date/time.
- Perform FR to store the Historical Fare Record.
- The amount of OC tax (transaction fee) and its settlement process is responsibility of the user.
