We are glad to inform you, carriers which already support ATC Reissue now automatically incorporates JN Tax as applicable at the time of Reissue.

Key Features

- At re-pricing time, ATC Reissue will now compute the **JN Tax** automatically to apply on the change penalty.
- The ATC entries automatically generate the applicable Penalty Fee into the TST, as a Tax Code/ Q Surcharge/Additional Amount/Service Element for EMD etc. based on each participating local Airline Policy.
