

## *Office profile field List of Authorized Ticketing Carriers (LAT)*

We would like to re-iterate about the recent enhancement in the Ticket Issuance/EMD/Refund on the basis of **LAT** - List of Authorized ticketing carriers that supersedes the Office profile fields APC and AET (Prohibited Carrier) respectively i.e. Agency will be able to issue the Ticket, EMD and process refund for only those carriers which are listed in LAT.

Pre requisite for LAT update is the Airlines authorization on the BSP link, post authorization LAT gets updated automatically in the respective office id.
